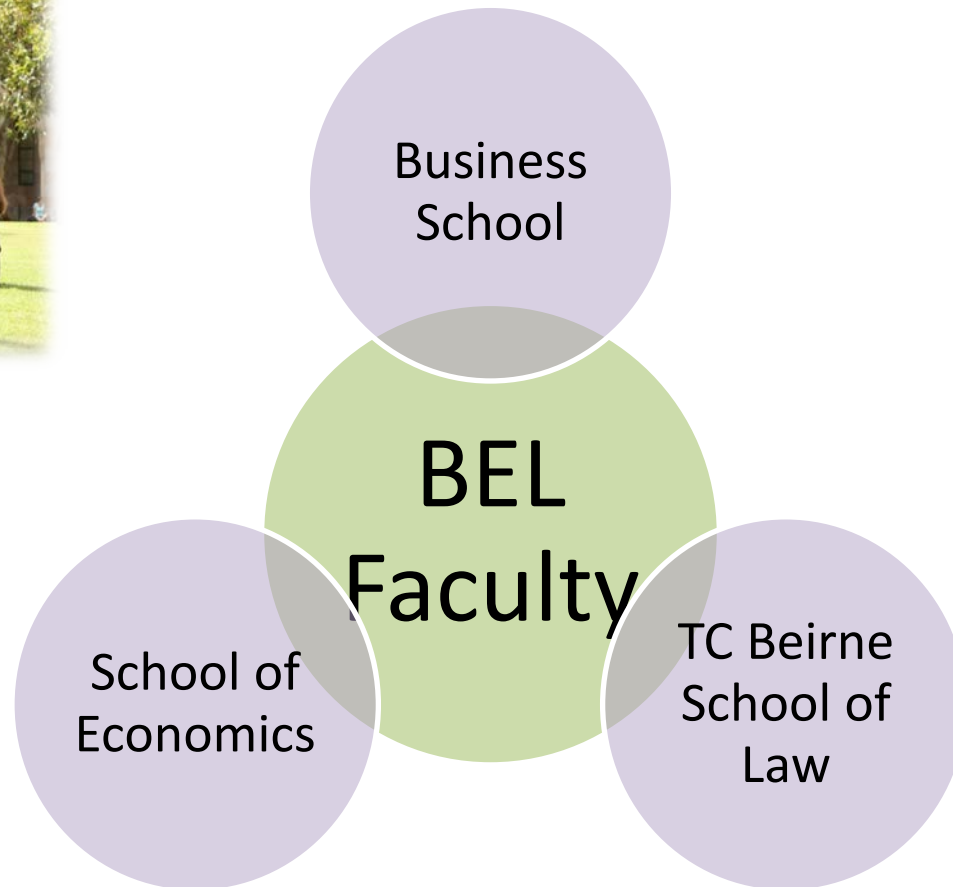

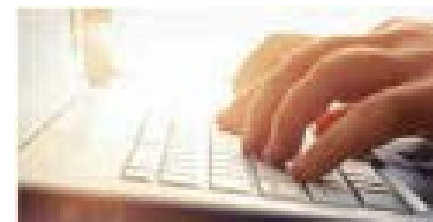
Database Management in Business

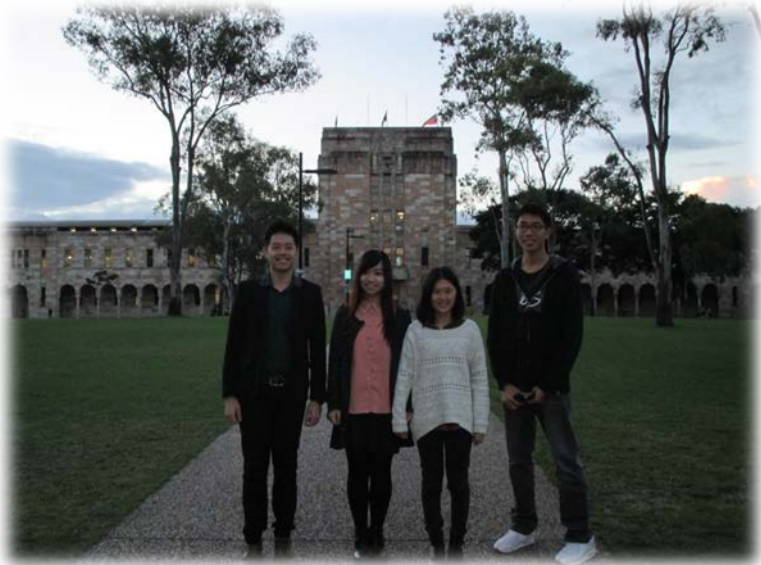

ESP: BRIDGING ENGLISH PROGRAM (ESP:BEP)

- The ESP:BEP is a 10-week, full-time (25 hours tuition per week) intensive English language pathway course for entry into UQ undergraduate and postgraduate programs.
- Students who successfully meet all ESP:BEP course exit requirements will gain assured entry to their UQ degree program and will not need to sit an IELTS/TOEFL test on course completion.
- Develops students' proficiency in all four skills: speaking, listening, reading and writing.

ENTRY REQUIREMENT

- For courses with 6.5 overall and 6 in every sub-band – can enter on IELTS 6.0 with no sub band less than 5.5 (for TOEFL IBT 78 and (Speaking, Listening and Reading: 17; Writing: 19))

Duration: 10 weeks

Dates:

- Monday 7 October - Friday 12 December 2014 for 2015 Semester 1 entry
- Monday 4 May - Friday 10 July 2015 for 2015 Semester 2 entry

Cost: \$4,400 (2015 fee, reference only)

Acceptance and payment deadline: 6 weeks prior to course commencement
